HISTORICAL BACKGROUND In the late 1950s many members of the design professions Engineers as well as Architects became concerned about their exposure to claims for professional malpractice and particularly about the increasing number of claims that had been successfully brought against them arising out of their Construction Phase activities. This led to special studies sponsored by the American Institute of Architects and the Engineers joint Counsel.
