Can you explain the concept of free cash flow and its importance

Answer Free cash flow FCF is the cash generated by a company after accounting for capital expenditures It s important because it shows how much cash is available to return to shareholders pay off debt or reinvest in the business FCF is crucial for assessing a company s financial health and its ability to generate value for investors

What is the difference between operating income and net income

Answer Operating income is the profit a company makes from its core business operations excluding any non operating income and expenses Net income on the other hand is the total profit after all expenses including operating expenses interest taxes and non operating income expenses

How do you calculate the weighted average cost of capital WACC

Answer WACC is calculated by multiplying the cost of each capital component debt equity by its proportional weight and then summing the results The formula is $WACC = \frac{D}{V} R_d + \frac{E}{V} R_e$ Where E is the market value of equity D is the market value of debt V is the total market value of equity and debt R_e is the cost of equity and R_d is the cost of debt

What is the difference between an income statement and a cash flow statement

Answer An income statement shows a company s revenues expenses and profits over a period focusing on profitability A cash flow statement however details the cash inflows and outflows from operating investing and financing activities providing insight into the company s liquidity and cash management

Can you describe the concept of the time value of money TVM

Answer The time value of money is the principle that a dollar today is worth more than a dollar in the future due to its potential earning capacity This concept underpins various financial calculations and decisions such as investment valuations and loan assessments

What is a discount rate and how is it used in financial analysis

Answer The discount rate is the interest rate used to discount future cash flows to their present value It s used in financial analysis to determine the present value of future cash flows such as in net present value NPV and discounted cash flow DCF analyses

How do you perform a discounted cash flow DCF analysis

Answer To perform a DCF analysis estimate the future cash flows the business will generate then discount these cash flows back to their present value using an appropriate discount rate Sum the present values of all future cash flows to determine the total value of the investment or business

Answer The main financial statements are the income statement shows profitability the balance sheet shows assets liabilities and equity and the cash flow statement shows cash inflows and outflows
