

Assessor Portal User Guide 6 - Completing an Assessment (ACAT)

Aged Care Assessment Team (ACAT) assessors can conduct assessments using the Integrated Assessment Tool (IAT) via:

- The assessor portal (this guide), the Aged Care Assessor app and uploading information onto the assessor portal when the assessor next has internet connectivity, a printed or blank copy of the IAT and entering information onto the assessor portal after the assessment has been undertaken.
- This user guide is for an assessor role in the system.
- If you have only been assigned an administrator role, you will not be able to view or complete assessments in the assessor portal.
- For more information about completing an assessment see the [Integrated Assessment Tool \(IAT\) User Guide](#).

From 1 July 2024, the Integrated Assessment Tool (IAT) will replace the National Screening and Assessment Form (NSAF). NSAF assessments that have been commenced and saved prior to 1 July 2024 (i.e. status "in-progress"), should be completed using the NSAF. All assessments commenced by assessors on or after 1 July 2024 will be completed using the IAT.

Also, from 1 July 2024, the Aged Care Assessor App will replace the myAssessor App for new assessments. Any assessments that are in-progress in the myAssessor App prior to 1 July 2024, will need to be completed using the myAssessor App. All assessments commenced on or after 1 July 2024, will need to be completed in the Aged Care Assessor App (or the Portal) using the IAT.
