(b)(7) (D), (b)(7) (F). The Rules may be accessed on the JAMS's Web site at www.jamsadr.com. Any arbitration hearing shall be held in Chicago, Illinois, unless the parties mutually agree otherwise or unless the arbitrator de termines that a different location would better serve the convenience of the parties. Notwithstanding the foregoing, the parties may, by mutual agreement, resolve their dispute by using any recognized online resolution.

This Arbitration Agreement is incorporated into and made a part of any and all agreements or contracts between the parties executed on or about the date shown or any related agreements or contracts entered into before, on or after the date.
