

## **NATURE OF EVIDENCE**

Evidence in audit is defined as any information used by the auditor to determine whether the information being audited is stated in accordance with the established criteria.

The information varies greatly in the extent to which it persuades the auditor whether the financial statements are fairly stated.

Evidence includes information that is highly persuasive, such as the auditor's count of marketable securities, and less persuasive information, such as responses to the auditor's questions of the client's employees.
