- 2.1 An object of mass 30 kg rests in an inclined plane forming  $30^\circ$  to the horizontal. The coefficient of friction between the surfaces is 0,5. (2 x5)

Calculate:

- 2.1.1 The component of weight of the block perpendicular to the plane

$$\begin{aligned} \bullet \text{ Perpendicular component} &= W \cos \theta \\ &= 30 \times 9,81 \times \cos 30^\circ \\ &= 249,36 \text{ N} \end{aligned}$$

- 2.1.2 The component of weight of the block parallel to the plane

$$\begin{aligned} \bullet \text{ Parallel component} &= W \sin \theta \\ &= 30 \times 9,81 \times \sin 30^\circ = 147,15 \text{ N} \end{aligned}$$

- 2.1.3 The frictional force

$$\begin{aligned} \bullet F_f &= \mu W \cos \theta \\ &= 0,5 \times 249,36 = 124,68 \text{ N} \end{aligned}$$

- 2.1.4 The smallest parallel force to the plane that will move the body up the plane

$$\begin{aligned} \bullet F_{\text{up}} &= \mu W \sin \theta + W \cos \theta \\ &= 147,15 + 147,15 \\ &= 294,30 \text{ N} \end{aligned}$$

- 2.1.5 The smallest parallel force to the plane that will move the body down the plane

$$\begin{aligned} \bullet F_{\text{down}} &= \mu W \sin \theta - W \cos \theta \\ &= 147,15 - 147,15 \\ &= 21,69 \text{ N} \end{aligned}$$
