Atrocities and International Accountability Edel Hughes, William Schabas, Ramesh Chandra Thakur, 2007 Rebuilding societies where conflict has occurred is rarely a simple process Where conflict has been accompanied by gross and systematic violations of human rights the procedure becomes very controversial.
